

How Do I Get My Money!

Once you have completed the other steps of arranging for your financial aid, any aid in excess of charges to your bursar account results in a refund. If you have signed up for direct deposit, your check will be deposited directly to your account on the first day of classes. Otherwise, it will be mailed to the address on your C-More account. To sign up for direct deposit or check the address on your C-More account, go to: <https://cmore.uchicago.edu/>. We urge you to sign up for direct deposit as well as electronic billing—both will save you time. Be sure to update your address there as well.

All Stafford funds will be applied to your Bursar's account and after all bills are paid you will receive a refund from the Bursar for the excess amount.

Pritzker Scholarship will be applied directly to your Bursar's account and refunds made available as with the Stafford funds.

If this is the first time you are receiving a Perkins loan at the University of Chicago, you must sign a Promissory Note. If you did not do this over the summer by mail then you must go to the Student Loan Administration Office (4th floor of the bookstore, M-F 9:00-4:00). Once the note is signed the money is placed in your Bursar account.

To receive Pritzker loan funds you must sign a promissory note. This is true whether you previously had a Pritzker loan or not. The funds will then be placed on your Bursar account and excess funds will be refunded to you.

Outside scholarships and loans are disbursed according to the regulations of the individual scholarships or loans. Consult with Lee Brauer, lbrauer@bsd.uchicago.edu to determine how these funds will be applied.
